Q1: WHEN DID LONDON ASHARA PREPARATIONS Q2. WHAT WERE SOME OF THE EXTERNAL TEAMS TRULY BEGIN?

In the summer of 2018 an indication was given that London should be doing araz to host Ashara Mubaraka. At that time, it was only five or six weeks before Ashara and we had no idea on how to start this type of project. But through regulation bodies, government officials and council agencies, we got significant advice and doors just began to open. That year, Ashara was declared in Indore and we took the opportunity to shadow first-hand how an event like Ashara worked from an operational and management perspective. After Ashara 1440, we immediately began our journey of planning and by early 2019 we were able to get the approvals and contractors required to feel confident about our araz to be the host city. That year the level of preparation and planning was the most heightened it had been in the forty year history of London tayyari, but Ashara was announced as Colombo. Two years later in Shehrullah this year, whilst Moula was in Misr, araz for London Ashara was done and an instruction given to review the possibility of making this dream a reality. It seemed an impossible timeline to achieve, but we were able to reactivate the teams who had worked so hard before and we were able to reach out and use the guide that we had already made. That same blueprint that was down on paper, we revisited it and we were able to just take off from where we left. Within weeks we had got to a stage that took us six or eight months to get to last time, and that's what gave us a solid platform to be able to be confident that we could actually pull this off.

WHICH HELPED US MANAGE THE EVENT?

One of our main contractors was GL Events, who are one of the largest event companies in the world and were also running the Commonwealth Games at the same time as London Ashara. For them to even take this on was based on the relationship that they had with us and also the fact that we had invited them to Colombo Ashara the year that Ashara was there. They had seen the live event, they understood it, we had a relationship with them and they wanted to do this event for us and the community at large. They wanted to be part of this history. However, because of their commitments to the Commonwealth Games, they really struggled to be able to fulfill our requirements at the speed we needed. Due to our relationship, they opened their book of contacts and we took on the role internally of the 'Principal contractor'. That meant handling health and safety, the procurement of structures, utilities, regulatory agencies and the Human resource requirement that came with that. We were able to bring the right people on board and create a team that could deliver and in fact did deliver this unbelievable event.

Q3. WERE THERE ANY MIRACULOUS EVENTS THAT HAPPENED DURING THE PLANNING OF THE EVENT? I think it's been mentioned a number of times that London Ashara in itself is a miracle. Nobody really thought it was possible, and it was not just from us. Even the external agencies, people who do this day in day out across the world, told us what we were trying to do was impossible. I can tell you that in 2022 this year, when we contacted these companies, every single one of them said it's impossible. They told us that it's not going to happen this year and emphasized that the Commonwealth Games, one of the largest events in the UK, is taking place on the same dates and will make resourcing our event almost impossible. 'You are not going to get the suppliers, you're not going to get what you need to run this type of event'. However, within 24 hours, within 48 hours, contractors just started calling us back, saying that we've looked into things, we've called a few people and somehow we think we can do this or at the very least we will give it our very best shot. Before we knew it, things started opening up.

For example, the types of structures that we required for the Mawaid and kitchen were of such size and quality, that there are only three or four of them in the whole of Europe, and they are normally booked out for 9-12 months in advance. But at the last minute there was a cancellation in the two or three weeks before we needed these structures and they became available to us. Again, that was unheard of. The company that we were working with said that this has never happened before. There was also an instance the night before *pehli*

waaz, that we were called to an emergency crisis

management meeting. The health and safety officers in charge of the site had made a decision. These were people that had worked with us for a long time and they were really very concerned and said to us, "We're very sorry. We never wanted to be in this position. But the site is not fit to be opened in the morning and we don't see any way that in the time left you can open for pehli waaz." We were completely broken as we had worked day and night for weeks and were sure we could be ready. The health and safety officials who had the authority to shut the whole site down had made it clear to us that we couldn't open. So what we then did was we sat with them and by 11pm that night we created a list of everything that needed to be done by 06:00 in the morning to be able to open. We gathered khidmatguzars from everywhere. We woke people up and got them to site and we did the manual labor that was required. We operated machinery onsite ourselves and using a manual labor force worked through the night. At 05:00 in the morning we completed the work on every single item on the list, and at 06:00 they inspected and they couldn't believe how much had been done in the 5-6 hours that we had. The officials deemed the site safe to be open and Ashara Mubaraka commenced as per Aqa Moula's ^{TUS} will.

Establishing a Community Hall TAHERI MOHALLA, MUMBAI



This year, with Aqa Moula's ^{TUS} benedictions, Taheri Mohalla (Mumbai) acquired a spacious 5300 sq. ft. *markaz* hall. It can accommodate 120 *thaals*, approximately. The new markaz is favorably convenient for Mumineen to commute towards, and is provisioned with the built-in infrastructure of a *madrasa*, a kitchen and a *mawaid*! The *markaz* has already showcased its worth during Ashara Mubaraka, where Instead of the usual 40 *thaals*, the count nearly doubled to 75!



Syedna Mohammed Burhanuddin's *tahqeeq* of the location of Rasul Imam Husain in Ashkelon, Israel

During his visit to Ashkelon, Syedna Mohammed Burhanuddin ^{RA} asked the Masjid's *imam*, Sheikh Abdul Qadir, about the location of Rasul Imam Husain. The *sheikh* replied that a hospital had been built near the actual location. Syedna asked the *sheikh* to accompany him and upon arriving, the *sheikh* pointed to a small, grassy hill with no signage. The *sheikh* said that this hill is the location of Rasul Imam Husain. Syedna Mohammed Burhanuddin ^{RA} asked, "Is this truly the location?" The *sheikh* replied, "Yes, this is it." Syedna Mohammed Burhanuddin ^{RA} said, "There used to be an ocean here." The *sheikh* immediately gestured in front of the hill and said, "The ocean is just ahead." Syedna Mohammed Burhanuddin ^{RA} then stood upon a *masalla* and declared that "This is truly the location of Rasul Imam Husain." The *sheikh* repeated, "I swear to Allah, this is the location of Rasul Imam



Husain." Syedna Mohammed Burhanuddin ^{RA} prayed *namaaz* and gave the *sheikh* two *qasida mubaraka* to pray. After praying the two *qasida mubaraka*, the *sheikh* said, "*Mabrook Mabrook*! Your words are pure, your thoughts are pure, your heart is pure, your tongue is pure and your actions are pure!" After that trip, Syedna Mohammed Burhanuddin ^{RA} built a *mashad* on that location which we know today as the *mashad* of Rasul Imam Husain ^{AS}.
